Integrating Inventory Control and Warehouse Management

West Chester Holdings Inc. relies on a global supply chain to bring its products to market. The company imports its inventory to a centrally located, 200,000-square-foot warehouse. Then, based on orders generated online and by an in-house sales team, the company distributes the inventory to mass retailers and specialty merchandisers throughout the United States and Canada for resale. Wanting to gain better inventory visibility and warehouse management processes and to improve service levels and billing cycles, the company began a search for a software solution to replace its disparate legacy applications. After evaluating dozens of solutions, West Chester Holdings chose it.wholesale, a qualified SAP® Business All-in-One partner solution, provided by SAP channel partner itelligence Inc.

Making the Right Choices to Streamline Integration

Working with itelligence, West Chester Holdings embarked on a 15-week “big bang” implementation. By making use of it.wholesale’s best-practice business processes and making only minor modifications, West Chester Holdings streamlined the implementation. In integrating its existing handheld inventory tracking devices, it streamlined efforts even further. Diligent planning and regular meetings helped to keep the project on track for team members, who had to divide their time between the implementation and day-to-day duties.

Early mapping and migration of the company’s master data enabled the team to practice with and test processes using actual data, accelerating learning and end-user acceptance. Employing a train-the-trainer approach, West Chester Holdings increased its in-house expertise to achieve self-sufficiency and reduce related training and maintenance costs. Before going live, the team performed hundreds of tests to eliminate surprises at the go-live, which went off without a hitch.

Reaping the Rewards of Greater Visibility and Improved Processes

By switching from manual and potentially error-prone, paper-based processes, West Chester Holdings has been able to improve its business processes and customer-service levels. By integrating inventory control and warehouse management, the company improved its overall inventory visibility and fill rates, turns over inventory more quickly, and has shortened billing cycles. At times of inventory overflow, West Chester Holdings can make use of a remote storage location while maintaining control with the software.

With the new efficiencies West Chester Holdings has gained through its direct-to-customer shipment program and improved warehouse management capabilities, it has optimized the use of its existing warehouse space and achieved capital expenditure savings of US\$30,000 per month.

More accurate, readily available data has led to greater insight into the business and reduced order entry and billing errors. Streamlined processes and increased productivity allow the sales staff to spend more time selling, and support staff can be reduced or reallocated to more strategic functions.

Looking Forward to New Opportunities

West Chester Holdings intends to leverage its investment in SAP software by expanding its warehouse facilities to speed time to market. The company also intends to expand its online vendor portal and build a customer portal, providing a direct-connect functionality for order creation and order-status updates.
